### From the Executive Director

I've been traveling our corridor to reach out to our existing and potential members to garner support and learn more about stakeholder concerns and interests. I traveled recently to PA where Rick Rovegno and I visited with those ranging from local fire and police to Transportation Secretary Richards. On the way home I spent some time in WV learning more about their corridor concerns and spoke with the Berkeley County Council. I participated in a Virginia Legislative session that focused on I-81 and traveled to TN to meet Transportation Commissioner Schroer and others at TDOT and the Lakeway MPO. I'm headed back to TN for a Freight Advisory Committee meeting on March 23. A more comprehensive list of outreach activities is included at the right.

Our Steering Committee has prioritized regular communication amongst coalition membership by sector and I'm happy to report that we've been able to facilitate four such meetings between both State-Level and Regional sectors. The first State-Level meeting was held in-person in Winchester in Nov. 2016 with attendees ranging from TN to PA. We are planning to continue these discussions and are planning to add comparable events with corporate members in the near future.

### A (Somewhat) New Direction

While there are myriad issues facing our corridor we're focusing our efforts in three primary areas that support the larger goals of safety, reliability, and quality of life. These are:

- **Incident Prevention**—Most crashes that result in major upset to the corridor involve trucks. Better freight information systems and vastly improved truck parking will reduce the risk of heavy vehicle crashes. We are currently preparing a multi-state freight information system and truck parking reservation system proposal. We are working with Schneider National to gain access to driver hours-of-service data to do a parking needs assessment.
- **Incident Management**—In many cases impediments to quick incident clearance can be addressed with better training, policy, legislation, and technology. We are working to become a clearinghouse of training information and events for the corridor. Cross-border tabletop sessions are also planned. Through our state-level sector meetings we're sharing information on new policy and legislation. We will also share information on the application of proven technologies that enable quicker clearance.
- **Corridor of the Future**—We have a great opportunity to lead the way in preparing our corridor for the future and for applying already proven methods in communication, automation, aerial-based sensing, and elsewhere to enhance safety, travel reliability, and efficiency. Our corridor is somewhat uniquely situated to lead the nation in these efforts due to our location, topography, weather, growth, and freight loading.
