Maryland has also worked on restriping to increase existing lot space and some capacity increases. Maryland has also seen D.M. Bowman, a member of our SFAC, develop private solutions, which is fantastic. Finally, we've had private non-truck parking businesses hear our plight and offer parking. Hollywood Casinos in Cecil County offers parking for truckers and we were able to work together to spread the word. While not a capacity solution, a key element in talking capacity is MDOT's use of data to communicate the demand - not another study but much needed analysis to engage decision-makers and the public on solving for capacity.

		develop consistent data feeds for work zones. Is there an opportunity to do something similar to support future Truck Parking Information Systems and eventually CAVs in the future? Apologies for the ignorance on this topic
		Katsikides, Nicole: Schneeberger, VTTI and TTI are working on a study under the SAFE-D UTC that touches on the data feeds and standards a bit. We will release the work later this year, but the goal was to look at how data can help identify supply and demand and if it can be useful as a data feed to drivers/companies. If so, what is the best format? We organize some thoughts and ideas on the data feeds, but more research on this is needed. Still - it is pushing the research in the direction of your question. I can share
		when it is ready.
		Schneeberger, JD: Also, it will make it easier for app developers to incorporate the multiple feeds from different agencies (private and public) into their apps.
